ISO 39001 Road Traffic Safety Management System provides a systematic tool for organisations to address road traffic safety risks and injuries that exist within the road network and in the workplace.

ISO 39001 aims to eliminate road fatalities and serious injuries arising from road traffic movements, and is applicable to all organizations of any size in public and private sector. The management system institutes periodic, quantitative targets to reduce deaths and serious injuries, as well as systematically address their cause factors.

The road safety management system can be integrated with the general management system of an organisation and with several parallel management system standards such as ISO 9001 (Quality) and ISO 14001 (Environment). ISO certified organisations will see smooth integration of this road traffic safety component to their existing systems, and gain added benefits from the unique elements in ISO 39001 that are not covered by any other ISO management system standard.
